Thence continuing with the East line of the said Southwest quarter of Section 15, South Nine degrees Twenty-five minutes Fifty-three seconds (09° 25' 53") West for Seventy-six and 99/100 (76.99) feet to a 5/8" iron pin set, said iron pin being at the Northeast corner of a 0.3 acre tract of land conveyed to L.B. & Betty Jones by deed recorded in Microfiche 86-0547CO3 in the Deed Records of Montgomery County, Ohio, said iron pin also bears North Nine degrees Twenty-five minutes Fifty-three seconds (09° 25' 53") East for Seven Hundred Forty-six and 01/100 (746.01) feet from a 3/4" bolt found at the Northeast corner of Lot 36 of the Plat of Harrisburg as recorded in Plat Book 2 Page 140 in the Plat Records of Montgomery County, Ohio;
