Nail marking the Southwest corner of a 0.82 acre parcel of land as conveyed to Harold Rieck by deed recorded in Microfiche 98-511C12, of the Deed Records of Montgomery County, Ohio, and the Northwest comer of a 3.50 acre tract of land as conveyed to Bernard C. Baker, Jr. and Hazel M. Baker by deed recorded in Microfiche 83-560E03, of the Deed Records of Montgomery County, Ohio;

Thence, North 87 degrees 50 minutes 43 seconds East along the common property line between the said 0.82 acre parcel and the said 3.50 acre tract a distance of 210.00 feet to an iron pin found, said iron pin parking a corner common with the Southeast corner of said 0.82 acre parcel and the Southwest corner of said grantor. Said iron pin also being THE TRUE POINT OF BEGINNING;

Thence, North 01 degrees 45 minutes 00 seconds West along the common property line between said grantor, and said 0.82 acre parcel a distance of 250.91 feet to an iron pin found, said iron pin marking a common corner with the Northeast corner of Lot 134 of said Mariann Country Estates Plat, as conveyed to Harold Rieck by deed recorded in Microfiche 98-511C12, of the Deed Records of Montgomery County, Ohio, and the Southeast corner of Lot 133 of said Mariann Country Estates Plat, as conveyed to Steffen-Schultz, Inc. by deed recorded in Microfiche 78-

386C03, of the Deed Records of Montgomery County, Ohio;

Thence, North 87 degrees 50 minutes 43 seconds East by a new division line, a distance of 15.00 feet to an iron pin set;

Thence, South 01 degrees 45 minutes 00 seconds East a distance of 250.91 feet to an iron pin set, said iron pin being on the North property line of said 3.50 acre tract;

Thence, South 87 degrees 50 minutes 43 seconds West along the common property line of said grantor, and said 3.50 acre tract a distance of 15.00 feet to the TRUE POINT OF BEGINNING and containing 0.086 acres of land, more or less, and subject to all legal easements, restrictions and agreements of record.
