## DESCRIPTION OF LAND

Jordan, by deed of record in Official Record 07113H16; Thence South 33 degrees 54' 48" West, along said centerline of Harrisburg Pike, a distance of 10.00 feet to a point; Thence North 56 degrees 58' 00" West, a distance of 290.00 feet to a point; Thence North 33 degrees 54' 48" East, a distance of 10.00 feet to an iron pin at the southwesterly comer of the Jeffrey A. Jordan 0.466 acre tract; Thence South 56 degrees 58' 00" East, along the southerly line of said 0.466 acre tract, a distance of 290.00 feet to the place of beginning, containing 0.067 acre, more or less.

Jordan, by deed of record in Official Record 07113H16; Thence South 33 degrees 54' 48" West, along the westerly line of said Jeffrey A.
